Mossyrock Blueberry Festival Vendor notes:

Booth spaces are 10x10, 10x20, or by special request.

Vendors must supply their own canopies and display materials.

Canopies must be weighted.

Limited electricity available for food vendors only.

The Festival provides basic liability coverage, we recommend having additional insurance.

Required Mossyrock City business license is included in booth fee.

Booth fees must be submitted with application.

Application and booth fees deadline: July 1st 2011.

We reserve the right to limit numbers of competing vendors. All vendors must have all legally required licenses and certifications and must comply with all state, county, and local laws. This is a family event. Drug paraphernalia or pro drug literature will not be allowed. Sexually explicate items and items with violent content will not be allowed. Guns or gun sales will not be allowed.
